THE CHALLENGE

The UN Global Compact challenges you to complete the **Doing Business with Integrity** course between **1 November–30 November 2025**.

This foundational e-learning course, developed in collaboration with the United Nations Office on Drugs and Crime (UNODC), equips learners with practical tools to navigate integrity dilemmas and promote ethical conduct. The Challenge is open to all and supports employees across roles in strengthening integrity practices. Participation requires an Academy account, which can be easily [created for free](#).

ACTION 1 30 OCTOBER
